Retaining the structure of the first book, this second edition has been expanded and updated with new text and illustrations, featuring more numerical problems with a wider scope. Readers will find much on the background to the hydrocarbon process industry, including details of centrally important operations as refining, heat exchange, cracking, polymerisation and hydrogenation. The chapter on offshore matters highlights some incidents that occurred since the first edition, while the topic of leaked gas detection has been introduced and there is considerable extension of the coverage of static electricity hazards. LNG, tight gas and coal bed methane also feature, while the chemical processing chapter has been extended to include hydrocracking, hydrodesulphurisation and hydrodenitrogenation. The COMAH (Control of Major Accident Hazards) regulations are covered and sign conventions for hazards are explained with illustrations.

This book aims to analyse all the critical factors (technical, political, economic, social and human) that could potentially accelerate or delay the maintenance and redevelopment of mature producing fields as well as the discovery and development of new conventional and unconventional resources. Insofar as in 2035, oil and gas will still account for more than half of the world primary energy consumption, the appropriate management of these critical factors is crucial to ensuring, at least in the medium term, the 'grail of growth'. However, the hope of achieving the 450 ppm targets of Copenhagen has been shattered, states the author – bad news for the human population, which is becoming more concerned with ensuring its short-term growth than with its long-term survival.
